The variance reflects new business, net positive cash flow and a very low client turnover/termination experience during the period. 4. The variance is due to strong performance coupled with new clients. 5. The variance is due to market appreciation and investor flows. 6. The variance is due to Northern Trust Asset Management funding \$3.8 billion in defined benefit assets for a client across three mandates in the second quarter of 2021. 7. The variance is due to a continued focus on the Canadian market, leading to new institutional wins in both public and private markets.
