² Under Rule 15c6-1 of the Securities Exchange Act of 1934, as amended, trades in the secondary market generally are required to settle in two business days, unless the parties to such trade expressly agree otherwise. Accordingly, purchasers who wish to trade the Notes prior to two business days before settlement will be required, by virtue of the fact that the Notes initially will settle in five business days (T+5), to specify alternative settlement arrangements to prevent a failed settlement.

Interest Payment Dates: Semi-annually on January 10 and July 10 of each year, beginning on July 10, 2022 (short first coupon).

Canadian Bail-in Provisions: The Notes are bail-inable notes (as defined in the

accompanying prospectus supplement) and subject to conversion in whole or in part — by means of a transaction or series of transactions and in one or more steps — into common shares of the Bank or any of its affiliates under subsection 39.2(2.3) of the Canada Deposit Insurance Corporation Act (the "CDIC Act") and to variation or extinguishment in consequence, and subject to the application of the laws of the Province of Ontario and the federal laws of Canada applicable therein in respect of the operation of the CDIC Act with respect to the Notes. See "Description of the Debt Securities — Terms Specific to Senior Debt Securities — Special Provisions Related to Bail-inable Debt Securities" and "Risk Factors — Risks Related to the Bank's Bail-inable Debt Securities" in the accompanying prospectus supplement and base prospectus.

Optional Redemption by Holders of Notes: None

Optional Redemption by the Issuer:

In certain circumstances where the Issuer has or will become obligated to pay additional amounts (as described in the pricing supplement), the Issuer may, at its option, redeem the Notes, in whole, but not in part, at any time before maturity, after giving not less than 10 nor more than 60 calendar days' notice to the holders of the Notes at a redemption price equal to 100% of their principal amount together with accrued interest, if any, to, but excluding, the redemption date. See "Terms of the Notes—Redemption for Tax Reasons" in the pricing supplement.

The Issuer may also redeem the Notes, at its option, as a whole or in part at any time and from time to time, prior to maturity, after giving not less than 10 nor more than 60 calendar days' notice to the holders of the Notes at a redemption price equal to the sum of (i) 100% of the principal amount of the Notes to be redeemed; (ii) the Make-Whole Amount (as defined in the pricing supplement dated January 5, 2022) discounted at the Treasury Yield (as defined in the pricing supplement) plus 7.5 basis points; and (iii) accrued and unpaid interest on the Notes to, but excluding, the redemption date. See "Terms of the Notes—Optional Redemption" in the pricing supplement.

US\$350,000,000 Floating Rate Senior Medium-Term Notes, Series C, due 2025, US\$750,000,000 1.950% Senior Medium-Term Notes, Series C, due 2027, and US\$600,000,000 2.450% Senior Medium-Term Notes, Series C, due 2032.

The settlement of the Notes is not contingent on the settlement of the concurrent offerings.
